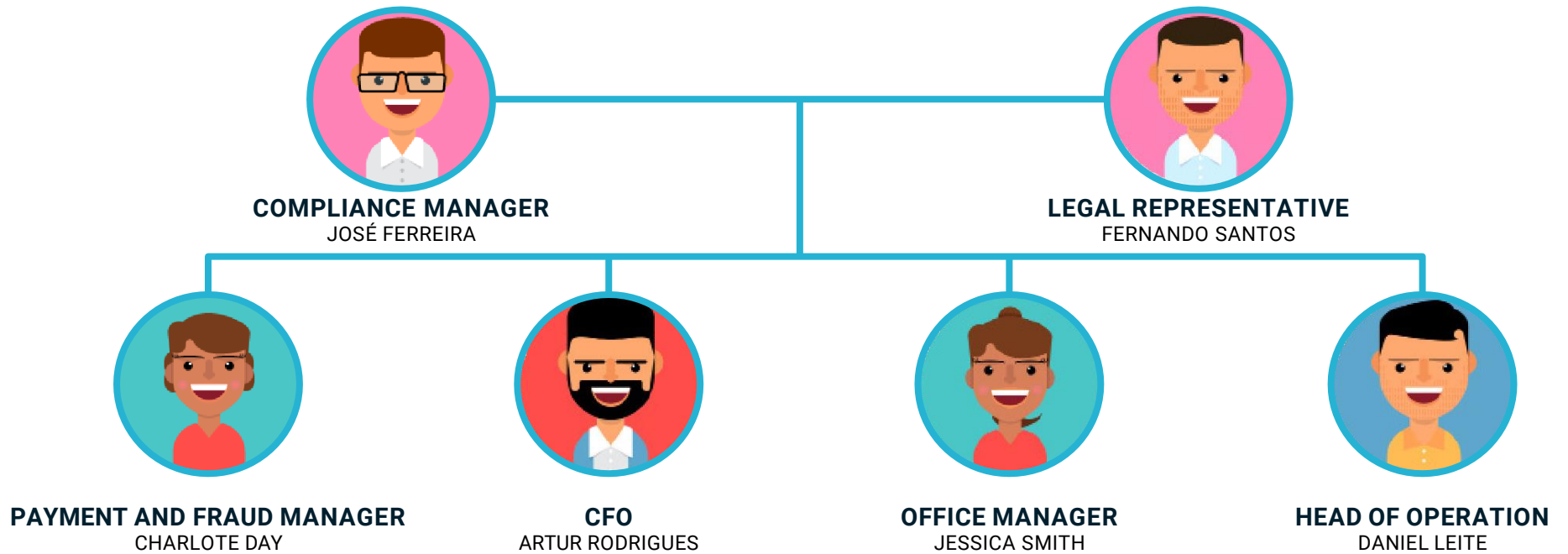

TO INCORPORATE A COMPANY IN CURAÇAO

Today Curacao is one of the most favourable jurisdictions to register an offshore company. Several reasons contribute to that – political stability of the country, economic growth and favourable attitude to foreign investments.

A common way to register a company in Curacao is to register a private company with limited liability, known as the Netherlands Antilles Besloten Vennootschap (NABV / N.V. or B.V.).

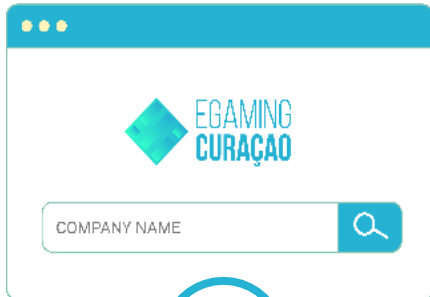
Company features:

- Freedom from taxes, if structured right
- 10% of shares must be registered in the Register of Shareholders
- Shareholders meet every year, Trustees are welcome to join the meetings
- Audits and keeping records is obligatory
- To escape taxation, the companies must act as investment or holding companies
- Income must be collected either in the parent company or in another jurisdiction
- Another type of company often registered is Public Partnership (limited partnership).

The main advantages of running business in Curacao:

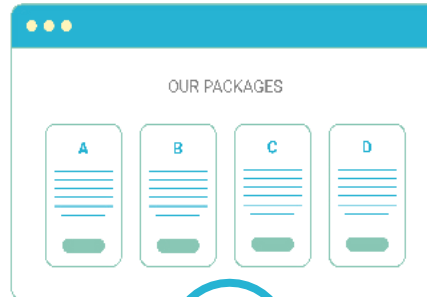
- Companies only pay 2% profit tax
- There are no limits on withdrawing dividends
- Licensing business is easy and fast
- Technical support for casinos is at a very high level
- No need to register an office in Curacao
